I agree for myself, my dog(s) and my guests and invitees to assume the risks and hazards that may be expected to arise from such activities, uses and interaction with other dogs. I agree that Glendale Pet Resort shall not be held responsible for injuries illness to myself, my dog(s), my guests or invitees other patrons and/or dogs who may be injured by my dog or by my acts or omissions or by the acts or omissions of my guests and invitees and I agree to indemnify handhold harmless Glendale Pet Resort for any and all costs, damages, claims or expenses that may result there from. I authorize Glendale Pet Resort to contact my veterinarian in order to confirm the health, temperament an vaccination history of my dog(s). If, in my absence, my dog should become injured, ill, suffer an ailment or is otherwise deemed in the sole discretion of Glendale Pet Resort to require immediate veterinary attention, Glendale Pet Resort is hereby authorized to consult with my veterinarian. If my veterinarian is unavailable or located at too great of a distance, Glendale Pet Resort is authorized to utilize the service of another licensed veterinarian to provide care for my dog(s). Further, should I be required to take my dog to a veterinarian after a stay or visit at Glendale Pet Resort I shall be solely responsible for any and all veterinary or other related or unrelated charges, costs or expenses an shall not seek indemnity or reimbursement from Glendale Pet Resort.

GLENDALE PET RESORT DAYCARE AND BOARDING RULES AND REGULATIONS

Our goal is to provide a safe, fun, healthy and stimulation environment in which social dogs can interact with other dogs and the caretakers that adore them! In order to ensure the health and safety of your dog and all other guests, we require all of the following in order to attend Daycare and boarding. Since Boarders are integrated into Daycare, they must also meet the following requirements:

1. Dog(s) must be at least three months of age.
2. Dog(s) over six months of age must be spayed and neutered.
3. They must be up to date with flea and tick prevention, otherwise we will have to apply it once they check in.
4. All dogs should be in good health, free of communicable diseases. We require current vaccinations record of DHLPP (sometimes called a 5n1 shot), Rabies, Parvo and Bordetella (canine cough). Bordetella must be administer within the past 6 months and no sooner than 10 days prior to check in.
5. All dogs must attend a brief initial interview before the first session of Daycare of the first day of boarding. A completed Application and profile and current vaccination record, must be submitted before checking in.
